During the NIPN seminar, audio and skype presentation was delivered by Dr.Patrick Kolsteren, from Ghent University in Belgium on the topic of "Nutrition Research Quality: Research duplication and quality, what researchers should do?". The presentation focused as to how quality research can

contribute in producing evidence and as such contribute to policy decision making.

The second presentation was delivered by Dr.Stephen Vosti from the University of California, Davis, on "Identifying and Cost-Effectively Addressing Micronutrient Deficiencies: The MINIMOD Tool Applied to Vitamin A Deficiencies in Young Children in Ethiopia."

The National Nutrition MER SC Meeting Discussed Various Issues

The National Nutrition Monitoring, Evaluation and Research Steering Committee (MER SC) meeting was held in Bishoftu on June 14-15, 2019.

Mrs. Aregash Samuel, Deputy Director of the Food Science and Nutrition Research Directorate of EPHI, welcomed the participants and encouraged the active engagement and commitment from the participants.

The workshop focused on the review of the 2018 National Nutrition Program performance and score card, in addition to this, nutrition stakeholder mapping draft report, the capacity need assessment preliminary results, along with the principles and practices of the capacity development, the NIPN activity update, the Food Based Dietary Guideline and the Household Income Consumption and Expenditure Survey (HICES) analysis were discussed.

The participants discussed how to strengthen the guidance and leadership role of the MER SC and the importance of planning. The Capacity Needs Assessment and the development of the Capacity Strengthening Strategy was discussed thoroughly.



Discussions were conducted on the formation of policy questions, the opportunity of initiating policy questions within universities and research institutions.

The AC also provides guidance on evidence synthesis advocacy and utilization of evidence generated. As applicable and, appropriate, it supports the uptake of key messages of NIPN outcomes by high level politicians. Additionally, the NIPN AC will be linking upward with the Ethiopian multi-sectoral nutrition governance structure such as, the National Nutrition Technical Committee and Coordination Body and ministries, as needed The Advisory Com-

mittee, which is comprised of a group eight high level experts with one secretary, has been established in a launch meeting held on May 20,2019 at Nexus hotel

The Advisory committee includes high level experts from Ministry of Health, Agriculture, Education, Women, Water, Irrigation and Energy ministry,

A Desk Review Conducted to Identify Potential Policy Questions



An internal desk review has been conducted by the NIPN team and policy translation unit of EPHI to identify nutrition related policy questions.

The review is one process of a NIPN activity in which policy questions were identified and further explored for anaylsis. The review was conducted in a meeting held on May 14-18 in Bishoftu.

The main aim of the meeting

was to gather documents from an open accessible data and to review policy, strategy and planning documents, research findings and other reviewed reports.

The topics covered during the desk review were urban nutrition, pastoral nutrition, nutrition and financial tracking and social protection.

He explained the Vitamin A intake among the non-breast feeding children in Ethiopia and concluded that fortification of edible oil with Vitamin A would reduce the prevalence of VA inadequacy among young children across the different regions although the impacts varied by region.

During the launch of the AC, the deputy director of EPHI,Dr.Getachew Tolera, explained the fact that despite great progresses, malnutrition remains a concern in Ethiopia. The country is addressing this by implementing the National Nutrition Program, and more recently, by validating the National Nutrition Policy.



It is important to consider that the implementation of the policy needs to be supported by evidence-based decision making and NIPN can support this process. In addition, NIPN will promote making better use of existing and underutilized data to overcome the challenges of existing data sets and reports. Since nutrition-related activities are largely demanding a multi-

sectoral approach, the establishment of the AC is a significant step to provide strategic guidance to the implementation of the NIPN.
